ORDER AND DECREE ORGANIZING DISTRICT, ISSUING CERTIFICATES OF ELECTION AND RELEASING BOND

THIS MATTER comes before the Court on the Motion for Order and Decree Organizing District, for Issuance of Certificates of Election and for Release of Bonds, filed by the Petitioner in regard to the organization of Erie Corporate Center Metropolitan District No. 2 (the "District"). 1) That a majority of the votes cast at the election held on May 4, 2004, in which the question of organization of the District was submitted to eligible electors, were in favor of organization, and that the election was held in accordance with Articles 1 to 13 of Title 1, C.R.S.

- 2) That the District shall be and is hereby duly and regularly organized in accordance with the requirements of Article 1 of Title 32, C.R.S.
- 3) That the District shall be known as "Erie Corporate Center Metropolitan District No. 2," the corporate name as designated in the Petition filed with this Court.
- 4) That the District is located in Weld County, Colorado, as more particularly described in Exhibit A, attached hereto and made a part hereof.
- 5) That the District shall be a quasi-municipal corporation and a political subdivision of the State of Colorado with all the powers thereof.

- 7) That the Clerk of this Court shall release to Petitioner the Bond in the amount of \$500 submitted in connection with the organization of the District.
- 8) That in accordance with Section 32-1-205(2), C.R.S., a copy of the approved Service Plan and the Town of Erie Resolution of Approval shall be incorporated by reference in and appended to this Order establishing the District after all other legal procedures have been complied with.

DESCRIPTION OF DISTRICT 2 "RESIDENTIAL TAXING DISTRICT"

A part of Section 10, Township 1 North, Range 68 West of the Sixth Principal Meridian, Town of Erie, County of Weld, State of Colorado, more particularly described as follows:

COMMENCING at the Northwest corner of said Section 10; Thence North 89°45'35" East along the northerly line of said Section 10 a distance of 30.00 feet to a point;

Thence South 00°08'14" East parallel with and 30.00 feet easterly of the westerly line of said Section 10 a distance of 30.00 feet to the POINT OF BEGINNING;

Thence North 89°45'35" East parallel with and 30.00 feet southerly of the northerly line of said Section 10 a distance of 1530.00 feet to a point;

Thence South 00°08'21" East a distance of 3673.28 feet to a point of curvature;
